

BOOKING GUIDELINES

1. Bookings:

Commences on: 16th August, 2024

Closes on : 15th September, 2024



- **3. Cancellation:** Failure to make payment as per schedule would render cancellation of stall booking / allocation. Also payments either part or in full are not refundable.
- **4. Transport Documents:** Participants shall take care to see that the transport documents of exhibits are full and complete to satisfy the statutory requirements of sales tax, central excise and customs to avoid any difficulties on route. The exhibits should be consigned in the name of participant themselves or their local agents.
- **5. Entry of Exhibits:** Exhibitor registration and Entry of Exhibits will be permitted only after making 100% payment for all charges.
- **6. Exhibits in Exhibits Out:** Authorised representatives of the Exhibitor should be present at the time of entry of exhibits at the venue.
 - 6.1 Installation of Exhibits:
 The exhibits can be installed on 26th September from 10 A.M. to 6.00 P.M.
 - 6.2 Removal of Exhibits:

After 9.00 A.M. on 30th September and not later than 1.00 P.M.

- **7. Sales:** Sale of any product in the Fair premises is subject to the Rules & Regulations of the Government of Tamilnadu and the Government of India as the case may be.
- **8.** Advertising in Fair Venue: Printed matter and advertising material may be displayed /distributed only in the stall and not in hall gangways or outside the exhibition hall.
- **9. Moving, Acoustic advertising, Music, Dance and any such performances:** Totally prohibited. The organisers shall be entitled to intervene and discontinue or remove the Person / equipment / restrict the show in case of disturbance. No exhibits shall be displayed in the walk way.
- **10. Photographs and Films:** Organisers have exclusive right to take photographs and films of the exhibition stands. Prior permission of the organisers will be essential for taking photographs and films by Exhibitors for area other than their own stands.
- **11. Force Majeure:** Under the conditions of Force Majeure, which also include strike, bandh, natural calamities including health hazards and other events and decisions beyond the control of the organisers are entitled to after the dates, duration or cancellation of the entire fair. In the event of cancellation of the fair, only 10% of the participation charges paid will be refunded after deduction of the costs already incurred by the organisers.
- **12. Limit of Liability:** The organisers are not liable in any form for any loss or damage to Exhibitors property at the exhibition site or injury to their personnel.
- **13. Insurance:** All the Exhibitors must arrange for comprehensive insurance coverage for their exhibits and their employees including public liability at their own cost.
- **14. General:** The participant shall use the space only for exhibition purpose & not for cooking, staying or washing. The decision of the convener of Property Expo 2024 will be final and binding in regard to change in layout and enforcement of these rules & regulations as laid down by the organisers.
- **15. Arbitration:** In case of any disputes between the exhibitors and the event organisers it shall be settled through arbitration by Tamilnadu Chamber of Commerce & Industry, Madurai.



RULES & REGULATIONS



- 1. Venue: Tirunelveli Trade Centre (Air conditioned), S.N.High Road, Tirunelveli.
- 2. Dates: Exhibition will be held from 27th to 29th September 2024
- 3. Timings: 9.30 A.M. to 9.00 P.M.
- **4.** Stalls located at the air conditioned main hall include pre fabricated octonorm system, fascia name of the exhibitors.
- 5. Basic Facilities:
 - **5.1. 600 sq.ft. stalls** 20 nos of lights, 2 nos. of 15 amps plugs, Tables -5 nos, Chairs 30 nos & a Dustbin. Power Maximum 1 Kw.
 - **5.2. 500 Sq.ft. stalls** 15 nos of lights, 2 nos. of 15 amps plugs, Tables -4 nos, Chairs 24 nos & a Dustbin. Power Maximum 1 Kw.
 - **5.3. 400 Sq.ft. stalls** 10 nos of lights, 2 nos. of 15 amps plugs, Tables 3 nos, Chairs 20 nos & a Dustbin. Power Maximum 1 Kw.
 - **5.4. 300 Sq.ft. stalls** 10 nos of lights, 2 nos. of 15 amps plugs, Tables 2 nos, Chairs 12 nos & a Dustbin. Power Maximum 1 Kw.
 - **5.5. 200 Sq.ft. stalls** 5 nos of lights, 2 nos. of 15 amps plugs, Tables 1 nos, Chairs 6 nos & a Dustbin. Power Maximum 1 Kw. The above includes wiring upto the main switch board provided in the Stall.
- 6. Electrical Power: Single Phase 220V AC 50 Hz
 - **6.1. Electricity Usage**: Free of cost as referred in Clause No.5 and no additional power shall be provided by the Organiser.
 - **6.2.** Individual generators of the exhibitors are not permitted.
- **7.** Additional facilities: Any additional furniture, light fittings and raw open space shall be of extra cost
- **8. Stall Charges:** Refer Layout
- **9. Security:** The organiser will provide round the clock service for the general surveillance of the Trade Fair Complex, if required, exclusive security guards can be provided at extra charges during installation and removal of exhibits.
- **10. Exhibits Handling:** The service of Cranes and Forklifts through authorised contractors will be available at extra cost. This cost has to settle directly with the contractor.
- **11. Application for Participation:** The exhibition must make application through Stall Reservation Form which involves acceptance of Trade Fair Rules & Regulations.
- **12. Allotment:** The allotment letter shall be sent through e-mail upon receipt of 50% advance. No application will be entertained without advance payment
- **13. Payments:** All payments towards any charges should be made by account payee.
